This report is to inform the Head of Procurement, Director of Support Services and the Police and Crime Commissioner of a recommendation to procure an alternative software solution for the provision of address information to front line officers and staff.

On the basis of our research and evaluation, agree to award a contract for the provision and maintenance of software to Aligned Assets Ltd.

The Contract is to maintain and improve access to current people, address and building information whilst realising significant saving on the 5-year use of a new software product.

4. Background and proposal

Because it will become unsupported, our existing software application requires an update prior to April 2014. However, when this occurs, it will create incompatibilities with our existing Compass software. To overcome this problem, the current supplier, Northgate, has quoted a cost of £22K per force. Through market research and access to the mandated SCC framework, we were able to identify a suitable alternative at a much reduced cost.
