1. Purpose of report

To seek approval for the allocation of £12,500 in the form of a crime and disorder reduction grant from the Victims Capacity Building Fund to Coordinated Action Against Domestic Abuse (CAADA). This is for the, whose activities will contribute to the priorities set out in the Police and Crime Plan for Essex, specifically, this project will lead to an improvement in the services to victims of crime in Essex.

2. Recommendations

It is recommended that we allocate £12,500 from the Victims Fund to CAADA for the supply of advice and intelligence to inform the development of the joint commissioning model for IDVA services across Essex, Southend and Thurrock from April 2015.

3. Benefits of Proposal

CAADA to provide OPCC with a clear set of practical recommendations regarding the development of the joint commissioning model for IDVA services across Essex, Thurrock and Southend. These new arrangements will

improve services for victims and reduce the likelihood of repeat victimisation and domestic abuse.

4. Background

The current system of funding and commissioning IDVA services in Essex is based on legacy agreements and an inconsistent method of collaboration. In seeking to commission a more effective arrangement from 2015-16 we are commissioning industry-experts CAADA to perform a review into existing services and how we could make use of best practice. CAADA will produce a report that will be invaluable to informing our commissioning specification.
