1. Purpose of report

1.1. To seek approval for the allocation of £2,000 in the form of a crime and disorder reduction grant from the NIF to Essex Police.

2. Recommendations

2.1. Approve the allocation of the NIF grant to roll-out a vehicle security day in conjunction with Kwik-fit centres throughout Essex.

3. Benefits of Proposal

- 3.1. Proposal is to use Kwik-Fit premises throughout Essex to promote a secured by design day involving Car number plate security. Catalytic Convertor security locks as well as general vehicle security. Kwik fit staff will do all the fitting Police representatives will be on site to general vehicle security advice. All the premises and staff fitters supplied by Kwik-Fit
- 3.2. The supply and fitting of the products are to be carried out for free which is felt may increase the numbers supporting the idea from both public and business.

4. Background and proposal

- 4.1 Crime figures for this type of crime throughout the county are growing and number plate theft in particular is a common crime to enable criminals to mask the use of a vehicle for other offences. Catalytic thefts are steady but are subject to spikes in offence reporting.
- 4.2 This project benefits from £5,000 match funding from Kwik Fit who will supply premises and staff for the initiative.
