## 1. Purpose of report

1.1. To seek approval for an allocation of £10,547 in the form of a crime and disorder reduction grant from the Hidden Harm Fund to Essex Police, whose activities will contribute to the priorities set out in the Police and Crime Plan for Essex.

#### 2. Recommendations

2.1. Approve the allocation of the Hidden Harm Fund grant to screen the #ididntknow awareness raising movie across cinemas in Essex

#### 3. Benefits of Proposal

- 3.1. The 60-second video for the Essex Police #ididntknow CSE (child sexual exploitation) campaign will be previewed in 9 cinemas across Essex. This will increase awareness of the campaign and signpost people to the Essex Police website where people can gain further information or be signposted to support
- 3.2. The project's main aims are;
  - Raising awareness of CSE among the general public
  - Raising awareness of the types of exploitation e.g. Peer on peer, etc.
  - Challenging stereotypes about CSE.
