## 1. Purpose of report

1.1. To seek approval for an allocation of £17,695 in the form of a crime and disorder reduction grant from the CSDF to Barnardo's whose activities will contribute to the priorities set out in the Police and Crime Plan for Essex.

#### 2. Recommendations

2.1. Approve the allocation of the CSDF grant to Barnardo's to deliver their 'Children Affected by Parental Imprisonment' (CAPI) programme.

#### 3. Benefits of Proposal

The project aims to:

- Reduce the risk of young girls becoming young offenders and part of the offending cycle which can lead onto potential community or custodial sentences.
- increase young girls personal resilience by raising their confidence and selfesteem to enable them to make better choices when faced with potential 'risky' behaviours.
- empower young girls ability to say 'no' and reflect on the consequences of their actions even if they are already on the offending pathway.
- address issues young girls face around drugs, alcohol, gang culture, antisocial behaviour and their social IT/carbon footprints.
- equip young girls with the necessary tools to make more positive choices and raise their aspirations to enable them to have the strength to be autonomous and value themselves as a member of their community.

#### 4. Background and proposal

4.1 The Barnardo's CAPI service in Essex provides information and advice to professionals and support to children, young people and their families affected

by imprisonment. The programme has a multi-agency collaborative approach and works alongside agencies including Schools, YOT's, Voluntary sector, Police and Probation Service.

- 4.2 There are five key elements to the CAPI program, being;
  - Partnership working with local prison and detainee establishments to offer advice to prisoners/detainees and their families through induction talks and family visits. Prisoners/ detainees can discuss support for their families in the community.
  - provision of 'Hidden Sentence' training to professionals around the criminal justice system, the effects on children and young people when having a family member in prison and local and national support services.
  - management of a multi-agency steering group for professionals where we review and discuss the CAPI service, share issues and data and provide opportunities to develop joint projects.
  - development of a referral pathway for support services across Essex by way
    of partnership working with Children's Centre's, Family Solutions, Health,
    Social Care and other agencies to provide home based support to families in
    the community and one to one support for school age children and young
    people within schools.
  - partnership working with other agencies to provide group based activities within schools
- 4.3 The programme will be delivered on a countywide basis and benefits from some match funding from Barnardo's.

## 5. Police and Crime Plan

Supports the following priorities in the Essex Police and Crime Plan;

- Ensuring local solutions meet local problems
- reducing hidden harm
- reducing youth offending and all types of re-offending
- tackling the consequences of alcohol / drugs abuse and mental health issues
- increasing efficiency in policing through collaborative working and innovation
