1. Purpose of report

1.1. To seek approval for the allocation of an additional £10,844 in the form of crime and disorder reduction grant from the 2016-17 Community Safety Fund to Thurrock Adult Safeguarding Board whose activities will contribute to the priorities set out in the Police and Crime Plan for Essex.

2. Recommendations

2.1. Approve additional funding of £10,844 to the Thurrock Adults Safeguarding Board.

3. Benefits of Proposal

- 3.1. This request for additional in-year funding follows an internal review of the Board's objectives and finances.
- 3.2. The additional funding will support the Safeguarding Board to fulfil its statutory function and promote the wellbeing of vulnerable adults across Thurrock. The funding will provide for a board manager and administrator, an independent chair, training and engagement activities, including an annual conference.

4. Background and proposal

- 4.1. This funding is in addition to Thurrock Adults Safeguarding Board '16-17 core grant of £7,906 (see OPCC decision 0017/16)
- 4.2. This additional grant would mean the PCC provides 25% of the Board's funding, with Thurrock Council and Clinical Commissioning Group supplementing the OPCC's contribution

5. Police and Crime Plan

- 5.1. Supports priorities in the Police and Crime Plan as follows;
 - Reducing domestic abuse and wider hidden harms
 - Reducing youth offending & all types of re-offending
 - Improving Crime Prevention
 - Tackling the consequences of drug and alcohol abuse and mental health issues
 - Supporting victims of crime
 - Ensuring local solutions meet local problems
 - Increasing efficiency in policing through collaborative working and innovation
