## PCC Hosts Unique Victims' Conference

On 14th March 2014, the PCC hosted a significant conference where victims of crime bravely spoke about their experiences and organisations came together to discuss victims' needs. The event entitled 'Building on Local

Strength; Victims Services Commissioning Conference' was held at the Oasis Church in Chelmsford. The jam-packed day was full of presentations, q&a sessions, brainstorming activities, workshops and some emotional real-life accounts. The most valuable part of the day was when victims spoke about their experiences of sexual violence and abuse, and how they had coped. They were supported by staff from South Essex Rape and Incest Crisis Centre (SERICC).

## PCC's Pathfinder Project Criteria Revealed

The fund for the PCC'S Pathfinder Projects is now open and it is aimed at Essex voluntary and community sector organisations.

Nick Alston, PCC for Essex, is keen to use this as an opportunity to work with local voluntary and community sector (VCS) organisations to ensure that victims are placed at the centre of the system and the services they receive best meet their individual needs to help them cope and recover. The Essex PCC would like to use some of this funding to allow local VCS organisations to

test some new approaches to victims' services.

Examples might include: 1. An opportunity to test out the delivery of services that already exist outside Essex but have not been tried locally

 Making existing services available to a wider audience or across a wider geographical area.
Supporting the development of new consortia or collaborative ventures between VCS organisations.
The PCC would also welcome proposals for ideas that do not meet the above criteria but that could help to develop the capacity and capability of the victims' services sector across Essex. Timescales

Recognising that this funding is time-limited and that the learning from the pathfinders needs to inform commissioning from the end of 2014 onwards, it is proposed that pathfinder funding could be made available to successful applicants for a six month period. Grants will commence from June 2014. To apply for a grant, please see the form attached to this newsletter.

## MOJ Announce Funding for Essex

The Ministry of Justice (MOJ) has confirmed that the total budget for all PCCs across the UK is £24million for all victims services. From October 2014 responsibility and funding for the majority of victims' support services will be shifting from Central Government (Ministry of Justice) to local PCCs. Essex has been allocated £640,000 to develop local capacity and commission restorative justice services.
